**LT. GOVERNOR JENNINGS UNVEILS RESULTS OF 2005 HURRICANE
VOLUNTEER EFFORTS**

*~Relief organizations report millions of hours of volunteer
service dedicated to 2005 hurricane recovery ~*

MIAMI – Lieutenant Governor Toni Jennings today announced the accomplishments of this year’s volunteer hurricane relief work, thanking the thousands of volunteers who generously provided more than 4.7 million hours of service during the 2005 hurricane season. Joined by representatives from voluntary agencies, the Lt. Governor spoke about the importance of volunteers in emergency response and urged Floridians to get trained and prepared for future disasters.

“This year, I witnessed firsthand the extraordinary depth of commitment our hurricane volunteers display in times of emergency,” said Lt. Governor Jennings. “Businesses, individuals and community and faith-based organizations continue to work tirelessly with great compassion, in the wake of natural disasters. They are a testament to the good in each of us.”

During the record-breaking 2005 hurricane season, volunteers logged more than 4.7 million hours of service with the total value of voluntary efforts and in-kind donations totaling more than \$105 million. Volunteers and voluntary organizations donated more than \$16.8 million worth of food and more than \$1 million worth of ice and water to assist millions of Floridians recover from the storms.

“For now and the foreseeable future, the need for volunteers and donations after hurricanes strike will be great,” said Volunteer Florida CEO Wendy Spencer. “We are grateful to the volunteers and relief organizations who contributed significantly to helping our communities recover from disasters. They are an integral component of Florida’s emergency management plan.”

Recovery from the 2005 hurricane season continues and the need for financial contributions is ongoing.
