







# 6 Days 6 Ramps - Ten Year Celebration







**6 Days 6 Ramps** is a multi-site collaborative service project to build ramps for persons with disabilities. Partners include:

- Volunteer Florida
- · Not-for-profit organizations
- Organizations that serve persons with disabilities
- Volunteer centers
- Faith-based organizations
- Private Sector/Businesses
- AmeriCorps and National Service programs

Now in its tenth year, 6 Days 6 Ramps began as a joint project between Volunteer Florida and the Florida Department of Environmental Protection AmeriCorps program (Florida State Parks). The project has evolved from a single community service project to a yearly six-day, multi-site community strengthening event.

- 1. Expand the role of persons with disabilities in improving their community through participation in national and volunteer service programs
- 2. Bring attention to the accessibility needs of persons with disabilities in Florida
- 3. Strengthen existing volunteer efforts to remove barriers that prevent persons with disabilities from participating in their community

# **GOALS**



These goals are accomplished by building wheelchair ramps for community members with disabilities who qualify according to federal low-income guidelines. AmeriCorps members, community volunteers and organizations serving persons with disabilities have collaborated on the service projects in the last ten years.

### **HISTORY**

The St. Andrews Inclusion Project marked the beginning of what eventually became the 6 Days 6 Ramps Community Service Project. After numerous meetings between Volunteer Florida staff and AmeriCorps Program Directors to develop active service opportunities to recruit persons with disabilities to become AmeriCorps members, the idea for a service project was suggested by an AmeriCorps Florida State Parks member.



During his service with the AmeriCorps Florida State Parks
Team located at St. Andrews State Park, Brent Bailey had
met a frequent park visitor who had contracted Polio when
he was young. His resulting disability affected his ability
to walk and for many years restricted his access the beach.
Brent approached his AmeriCorps Program Coordinator
Matt Allen with the story and Matt contacted Volunteer
Florida with the idea of building a long ramp to provide
beach access for visitors who use wheelchairs and have
ambulatory disabilities.

Although a project of this magnitude was not in the St. Andrews budget, Mike Bullock, then Assistant State Director for the Florida State Parks, supported the idea of engaging volunteers with disabilities and made funds available to build a 325-foot long boardwalk located behind the Jetty Store at the St. Andrews State Park in Panama City.

Ability1st, a Center for Independent Living in Leon County, assisted Volunteer Florida in reaching out to persons with disabilities to volunteer for the project.

# THE BEGINNING

After the success of the St. Andrews Service Project, Matt Allen approached Volunteer Florida to explore the possibility of replicating the project in the community. Matt talked about the value he felt the project brought in helping his members connect with the community. If we could replicate the project, he believed it would have a more profound impact on the development of his AmeriCorps members.

Volunteer Florida staff shared the idea with Ability1st, who was in the ongoing process of recruiting volunteers to design and build wheelchair ramps for low-income community members with disabilities in Leon County. The Ability1st ramp building program, like others across the state, relies on volunteers to run the project. Because of limited funding and volunteers, the waiting list for ramps had grown to thirty individuals in the greater Tallahassee area. Matt felt that his AmeriCorps members could complete at least six of the ramps; and, based on that number, Matt suggested calling the project "6 Days, 6 Ramps."

6 Days 6 Ramps has been replicated across Florida since that original project in 2002. In that time, 1445 volunteers, 66 of whom were volunteers with disabilities, have completed 174 ramps.

From the beginning of 6 Days 6 Ramps, **Ability1st** has been a steadfast partner. As a Center for Independent Living, Ability1st, which is part of a nationwide network of Centers for Independent Living, works in partnership with persons with disabilities to maintain or improve their

level of independence. The first three years of the 6 Days 6 Ramps Community Service Project were dedicated to assisting Ability1st in reducing the number of ramp recipients on its waiting list. ## **TEN YEAR ANNIVERSARY**

In 2012, Volunteer Florida celebrated ten years of the 6 Days 6 Ramps Community Service Project. This year's event came full-circle with the return of Matt Allen, former AmeriCorps Program Director for Florida State Parks. Matt was the original volunteer coordinator and construction supervisor who led volunteers and AmeriCorps members for the first three years of 6 Days 6 Ramps Projects. Now Assistant Park Manager for Grayton Beach State Park, Matt joined Volunteer Florida CEO Chester Spellman, Volunteer Florida staff and members of Faith Presbyterian Church to complete a ramp for a resident in Gadsden County.

Volunteer Florida was able to fund two 6 Days 6 Ramps Community Service Project sites for 2012. With support from the Brain and Spinal Cord Injury program, Ability1st in Leon County and The Center for Independent Living in Central Florida in Orange County were able to stretch their financial resources to assist additional community members with disabilities to secure a wheelchair ramp.



For Floridians who sustain a traumatic brain or spinal cord injury, the Florida Department of Health Brain and Spinal Cord Injury Program provides assistance in navigating the rehabilitation and recovery process through a statewide network of case managers. Additional assistance provided includes acute care, inpatient and outpatient rehabilitation, transitional living, assistive technology, home and vehicle modifications, nursing home transition facilitation, and long-term support for survivors and families through contractual agreements with community-based agencies.
