Volunteer Florida

Volunteer Florida was established in 1994 by the Florida Legislature to administer grants under the National and Community Service Trust Act of 1993.

Volunteer Florida is the Governor's lead agency for volunteerism and national service in Florida.

Volunteer Florida is governed by a Board of Commissioners appointed by the Governor and approved by the Florida Senate.

Focus Areas for National Service



AmeriCorps places thousands of teachers, tutors, and mentors into low performing schools, helping students succeed in school and gain skills necessary to get 21st century jobs.

Education



Members build trails, restore parks, protect watersheds, run recycling programs, and promote energy efficiency, weatherization, and clean energy.

Environmental Stewardship



From forest fires and floods, to hurricanes and tornadoes, AmeriCorps members have provided critical support to millions of Americans affected by disasters since 1994.

Disaster Services



AmeriCorps supports the military community by engaging veterans in service, helping veterans readjust to civilian life, and providing support to military families.

Veterans and Military Families



AmeriCorps increases access to health services, provides nutrition education, alleviates hunger and supports independent living and social support services.



Healthy Futures

AmeriCorps Offers **Tangible Benefits**

Most AmeriCorps members receive student loan deferment, training, a living allowance and health insurance. After you complete your term of service, you will also receive a Segal AmeriCorps Education Award to help pay for college, graduate school, vocational training or to repay student loans.

AmeriCorps Members commit to serve a full year and can serve:

Full-Time – 1700 Hours

Reduced Full-Time – 1200 Hours

Half-Time – 900 Hours

Quarter-Time – 450 Hours

Minimum Time – 300 Hours



Examples of AmeriCorps Service

Provide **tutoring** and **mentoring** to students

Provide independent living and **financial literacy** to persons with **disabilities**

Provide **career coaching** and **job skills** training resulting in **employment**

Remove **invasive exotics** from public parks, **restore habitat**, visitor **education**

Home repair and housing units made available to disadvantaged individuals

Increase **financial literacy** or **health access** services for individuals

Disaster preparedness, mitigation and **recovery**



Things to Know

1

AmeriCorps programs are funded through federal grants.

2

Organizations apply to Volunteer Florida through a competitive process for a grant to support a minimum of the equivalent 10 full time members (i.e. 20 half time members).

3

The host or lead organization fully manages the program at the local level and includes 1 FTE or the equivalent in budget for program management.

4

AmeriCorps members are not staff and can not be placed in an administrative function.

FY2021 AmeriCorps Competitive RFP (Volunteer Florida)

CDFIs

- A joint initiative of the CDFI Fund and CNCS, the **Economic Mobility Corps (EMC)** places full- time AmeriCorps members at Certified CDFIs to enhance their capacity to provide financial literacy, financial planning, budgeting, saving, and other financial counseling activities in distressed and underserved areas.
- **Economic Mobility Corps** members will be placed in Certified CDFIs and will receive training on the principles of financial counseling and financial literacy.
- A Certified CDFI is an entity that the CDFI Fund has officially notified that it meets all CDFI certification requirements.
- Only Certified CDFI's are eligible to receive EMC members.

FY2021 AmeriCorps Competitive RFP (Volunteer Florida)

Sample AmeriCorps Member Position Description

- Conducting community outreach and recruitment of clients to the CDFI's counseling and planning services and programs;
- Assisting or conducting orientation sessions for new clients to explain services;
- Providing financial planning workshops and individual financial counseling, including conducting group education meetings
- Assisting in the development and execution of marketing strategies to promote client participation;
- Providing clients with information on the different financial products and services
- Conducting scheduled follow-ups with clients to ask how they are doing, find out if they need additional help, and to help them stay engaged;
- Performing administrative duties that support the CDFI's activities, including but not limited to, coordinating meetings, preparing presentations, conducting research, reviewing training and outreach materials, reviewing applications, and developing material that supports the financial counseling and outreach activity

FY2021 AmeriCorps Competitive RFP (Volunteer Florida)

- Budget Instructions

- Administrative/Indirect Costs – 5% Total
 - Corporation Fixed (Section 1 + Section 2 x .0526 x .60)
 - Commission Fixed (Section 1 + Section 2 x .0526 x .40)

Budget Example

Applicants can request the maximum of \$16,300 per 1 Member Service Year (MSY).

An applicant requesting 10 full-time members would apply for a \$163,000 grant.

1 full-time member = 1 MSY

Cost per MSY = \$16,300

10 full-time Members = 10 MSY

10 MSY X \$16,300 = \$163,000

Match: 24% cash/in kind of the total grant

Match Example:

10 full time members:

- Approximately \$163K federal request
- Minimum match estimate \$52K

Source of Match
Type: Cash or In Kind

20 full time members:

- Approximately \$326K federal request
- Minimum match estimate \$104K

Examples: In Kind Donations, Local Foundation Grants, School District, State and Federal grants, Agency General Revenue

Budget Reminders

Calculations should be itemized and in equation format

Minimum living allowance for full time members is \$15,100

The cost per MSY has increased to \$16,300

Be sure to Include background check costs for all staff and members charged to the grant either Federal or Match

Include the Source of Funds information in Section III and the dollar amount in this section should total the dollar amount in the budget

Budget Travel costs for at least 3 staff members to attend 3 VF trainings (2 in Tallahassee, 1 (Orlando, Miami, Jacksonville, Tampa)

Commission Fixed is required and must be budgeted in the CNCS section only

Be sure to include costs for member training, member gear, worker's compensation, and health insurance for members if FT

FY2021 AmeriCorps Competitive RFP (Volunteer Florida)

Application Instruction via eGrants system

- A. New Applicants: When submitting your application into the eGrants system, under the “Creating an Application” box (in the lower left hand corner of the page) click on “New”.
- B. For Re-compete or Continuation Applicants (applicants that are currently funded by Volunteer Florida): When submitting your application into the eGrants system, under the “Creating an Application” box (in the lower left hand corner of the page) click on “Continuation/Renewal”.
- C. All applicants must select the following NOFA: **FY 2021 AmeriCorps State and Territory Commission (New and Continuation) (Due date: 1/6/2021)**
- D. All applicants must select Florida from the state dropdown listing. Applicants should see that their application is linked to the Volunteer Florida Prime Application Grant ID Number: 21AC230084

FY2021 AmeriCorps Competitive RFP (Volunteer Florida)

Supplemental Documents (New/Recompete)

- The most recent audit report including the management letter and the schedule of findings and questioned costs. If an annual audit is not required, please submit a letter to document.
- Operational and Financial Management Survey (OFMS). Please submit as a word document
- Completed provider assessment questionnaire.
- Certification of 60 day operating capital.
- Most recent agency-wide YTD consolidated financial statement and balance sheets.
- Evaluation documents per NOFO guidance.

What Does it Mean to “operate” an AmeriCorps Program?

The AmeriCorps program becomes yours!

Your organization must recruit and manage AmeriCorps members

Your organization must manage payment of AmeriCorps member living allowance

Your organization will develop local partnerships

Your organization will track and report progress

Your organization will submit monthly cost reimbursement invoices and support documentation.

Timeline

- **October 13, 2020** – Technical Assistance Calls
- **October 14, 2020** – AmeriCorps Application FAQs posted (anticipated)
- **November 2, 2020, 5:00 p.m. EST** - Applications due in eGrants and supporting documentation submitted
- **November 2 – November 20, 2020** – External and Internal Review
- **December 3, 2020** - Clarification provided to applicants considered for funding
- **December 14, 2020 by 5:00 p.m. EST** - Revised AmeriCorps Applications due in eGrants
- **December 18, 2020** – Volunteer Florida Commissioner review and approval (anticipated)
- **January 6, 2021** - Estimated submission of approved funding recommendation to CNCS
- **August 1, 2021** - Anticipated contract start date
