

#### **FY2023 Application Instructions**

Continuation Requests, Pg. 13 Application Instructions

DO NOT MODIFY ORIGINAL NARRATIVE FIELDS. Information should be provided in the Continuation Changes narrative field as relevant. Include a header in this section with the year 2023.

- Changes in Operating Sites
- Significant Changes in Program Scope or Design
- Changes to Performance Measures
- Significant Changes to Monitoring Structures or Staffing
- Budget revisions (detail provided in section VI).

The page limit for the Continuation Changes field is six pages, as the pages print out from eGrants.

Any continuation applicant not requesting changes that fit within the above categories should enter "N/A" in Continuation Changes. AmeriCorps expects that most continuation applications will not be requesting changes.

## Administrative/Indirect Costs – 5% Total

- Corporation Fixed Calculation (AC Section 1 + AC Section 2 x .0526 x .60)
- Commission Fixed Calculation (AC Section 1 + AC Section 2 x .0526 x .40)
- If you have a Federally Approved Indirect Cost Rate, you <u>must</u> use it and you will see page 79, specifically B, to calculate.



### **Budget Reminders**

<u>ALL</u> calculations should be itemized and in an equation format for both Federal and Match.

Minimum living allowance for Full-Time members is \$17,600.

The cost per MSY can't exceed \$23,000 for both Fixed and Cost Reimbursement Grants.

Be sure to include background check costs for all staff and members charged to the grant either Federal or Match.

Include the Source of Funds information in Section III; the dollar amount in this section should match the total dollar amount in the budget.

Budget Travel costs for at least 2 staff members to attend 2 VF trainings (1 in Tallahassee, 1 in Orlando, Miami, Jacksonville, or Tampa) – 3 if you have new program or finance staff.

Commission Fixed is required and must be budgeted in the AmeriCorps column only.

Be sure to include costs for member training, member gear, FICA, workers' compensation, and health insurance (health insurance is required for Full-Time members).

There is a match requirement for the 2023-2024 contract year.

- Fixed Amount applicants must select the following NOFA: FY 2023
   AmeriCorps State and Terr Comm Fixed Amount, EAP (New and Continuation) – (Due date: 1/4/2023)
- You must select Florida from the state dropdown listing. Fixed applicants should see that their application is linked the Volunteer Florida Prime Application Grant ID Number: 22ES249612.

#### **Public Health AmeriCorps**

AmeriCorps is also offering the Public Health AmeriCorps Funding Opportunity where single state applicants must apply through State Service Commissions (Volunteer Florida).

- Public Health AmeriCorps applicants may request up to \$28,000 cost per MSY, there is no match required and applicant's program design must address Public Health Performance Measures.

- November 21, 2022 Clarification provided to applicants considered for funding
- December 8, 2022 by 5:00 pm EST Revised AmeriCorps Applications due
- December 12, 2022 Volunteer Florida Commissioner review and approval
- **December 27, 2022** Submission of funding recommendation to AmeriCorps
- May 2023 Funding Notification from AmeriCorps
- August 1, 2023 Anticipated contract start date
