Florida Commission on Community Service's 2025-2026 Annual Regulatory Plan

Pursuant to section 120.74, Florida Statutes (F.S.), the Florida Commission on Community Service has prepared the following Annual Regulatory Plan.

Section 120.74(1)(a), F.S.

The plan must include a listing of each law enacted or amended during the previous 12 months which creates or modifies the duties or authority of the agency. The following Laws of Florida and Florida Statutes were enacted or amended during the previous 12 months which create or modify the duties or authority of the Administration Commission: There are no laws that meet this criterion.

Section 120.74(1)(b), F.S.

This section requires that the plan include a listing of each law not otherwise listed pursuant to subsection (a) which the agency expects to implement by rulemaking before the following July 1, except emergency rulemaking. There are no laws that meet this criterion.

Section 120.74(1)(c), F.S.


This section requires that the plan include any desired update to the prior year's regulatory plan or supplement published which was published pursuant to section 120.74(7), F.S. The Florida Commission on Community Service does not have any updates to its 2024-2025 Annual Regulatory Plan.


Section 120.74(1)(e), F.S.

Because of the limited number of rules promulgated by the Florida Commission on Community Service, all the rules will be reviewed in year one.
